Developing multimedia skills and integrating instructional multi-media applications into CTE courses

This course focuses on the use of multi-media hardware and software in business education. Students will learn to use these technologies to access and manipulate information in an efficient manner. Effective procedures for organizing resources and working with Business education students will be explored. Instructional content will include:

- An overview of multimedia technologies
- Using of images, audio and video in the Business Education classroom
- Skill and knowledge using application software
- Project design and development
- Ethics/Security/Safety when incorporating multimedia projects into instruction

Students will understand the operation, application, and function of multi-media applications in business settings. Course activities will focus on developing instruction content through the use of multi-media applications, decision-making skills, and communications solutions.

This course promotes the UNL College of Teaching and Human Science's Scholar-Practitioner Model. The four areas of the model are emphasized in the goals, requirements and assessment of this course:

The Curriculum: Specialty studies, school curriculum.

The Learners: Developmental level, special needs equity, assessment,

evaluation

Teaching Processes: Planning, classroom management, teaching methods,

decision making skills

The Profession: Equity, technology, society, ethics

Instructional Approaches:

This course will incorporate a variety of activities and assignments that will be planned and conducted in an effort to model/suggest approaches that are relevant to and appropriate in business education classrooms.

Course Goals:

- 1. To demonstrate an understanding of the correlations between the National Standards for Business Education and the Nebraska Department of Education Career and Technical Education Standards.
- 2. To demonstrate an understanding of the business education curriculum with respect to the use of multi-media.
- 3. To be able to plan and implement a variety of instructional approaches based on a constructivist view of learning.
- 4. To be able to identify and accept the challenges and opportunities in using and teaching multi-media applications, including:
 - Concept development
 - Interactive design
 - Project development
 - Presentation
- 5. To develop competence in assessment of multi-media applications in business education.
- 6. To develop ways to enhance understanding and appreciation of diverse cultures and to incorporate culturally relevant teaching.
- 7. To engage in reflection as a regular part of business education teaching and learning.
- 8. To demonstrate progress in awareness and support of students as individuals and as learners including learning styles and languages.

Course Objectives

- 1. Explore various ways of thinking about media and the message conveyed.
- 2. Demonstrate how to use a variety of multimedia tools to enhance learning.
- 3. Evaluate existing multimedia products that can be used to design instructional and enhance the learning.
- 4. Apply theory and principles of learning, instructional design, and perception to the design of instructional media products.
- 5. Demonstrate proficiency with common software applications
- 6. Apply copyright law, fair use policies, and creative common regulations to the ethical development of electronic multimedia to support learning.
- 7. Identify guiding principles to promote students' safe and ethical use of the Web.
- 8. Design learning experiences that engage students in individual and collaborative learning activities.
